Thanks for the call yesterday. Here is the "critical success factors" draft that is modeled after CalWater Fix. Garwin is planning to share this Katrina and the CORE team. cc'ing Dan, since you are suggesting that the three of us connect.

I spent another hour with Garwin this morning, trying to get further up to speed on what is happening at CORE team. He said that at the meeting last week, the CORE team was handed very specific changes to document that they had never seen before or discussed, with many very significant changes from the current NMFS RPA, and that these were "handed to them by management." The process seems to be focused at this point on providing

comments back to Reclamation by July 11th. I've asked Garwin to be ready with that July 11th submittal to also provide any constructive ideas on changes we might want to see further evaluated, as well as clarifying any issues that he thinks need to be elevated to Directors level.

I'm happy to meet with you and Dan to discuss further. I'm around next week - - but know a lot of people have it off.
