Hello all -

It looks like December 12 is our day. I have heard back from the Yurok that they would like to meet that afternoon, and are willing to meet in Weaverville or Redding. The Hoopa also want to meet December 12, in their valley, and are leaving the time up to us (so morning).

The fastest way to get to the Hoopa by driving appears to be Highway 5 to Redding and then 299.

I would propose, for those traveling from Sacramento:

Travel the afternoon of 12/11 up to Redding. Spend the night in Redding.

Tuesday, 12/12: 9:30 am meeting with the Hoopa (this is 2.5 hours from Redding)

Tuesday 12/12: 2pm meeting with the Yurok in Weaverville (1.5 hours from Hoopa)

Tuesday night: Drive back to Sacramento from Weaverville.

Please let me know if you prefer a different approach, or want to fly, etc.
