Hi, Garwin—

Attached are the updated notes incorporating some of Jeff's and your comments. I'm not sure whether (or what) changes are actually needed to respond to the remaining comments. Perhaps we can talk through that this afternoon.

(I'm also attaching the Water Level and Water Quality Response Plans as requested via your comments on the notes.)

As an update, OCO staff met with CVO staff last Friday to discuss coordination between DWR and Reclamation for preferential pumping. We will be developing a letter agreement similar to, but separate from, the regular JPOD letter agreement, for any wheeling done at Jones for the SWP. The new letter agreement will provide for no conveyance charges for either project when like amounts of water are moved under preferential pumping and during emergencies and maintenance outages. The new agreement would be in place by January 2019.

Finally, I don't have an agenda for this afternoon beyond continuing our discussion from April 2. However, if you have specific items you would like to see on an agenda, please let me know.




