I just got out of a meeting with Dave Mooney, Katrina Harrison, Maria, and myself, where Reclamation provided updates on all 3 tracks of the ROC on LTO, and Dave mentioned a 1:1 ratio for all water year types as a likely action for track 1.

It's time, or maybe past time, for you to brief me on your conversations with Armin about the San Joaquin action, what you've said, where you guys landed, next steps, etc.
