As part of the Track 1 ROC on LTO process, Reclamation has shopped several alternatives to Action IV.2.1 (the I:E ratio action in the RPA of the 2009 NMFS LTO BiOp. Especially as part of Track 1 (which is supposed to include relatively easy-to-implement, low-hanging-fruit types of projects), the proposed alternatives are....challenging. This issue has been elevated to Maria and Federico's level and **Maria has asked for the WODC's ideas on "alternatives to the I:E ratio in IV.2.1 that provide equivalent protection"**.
