Ben, FYI, the I:E ratio document says 4:1 never implemented, and that's not accurate. WY 2017 was (eventually) WET on the San Joaquin and we were in the Vernalis flow offramp from 4/1-5/14 (no I:E ratio in effect) and from 5/15-5/31 (after Vernalis flows fell a bit), the 4:1 I:E ratio was in effect.
