CDFW performs angler surveys on Central Valley streams, and data from these surveys are used to estimate steelhead harvest and fishing effort. However, these estimates do not appear to be regularly reported. Available data on angler retention of hatchery-origin steelhead suggest an increase in retention since the 2010-2011 regulatory cycle (CDFW 2015[\[BE1\]](#) [\[NH2\]](#)). Mean retention from 2007-2008 through 2009-2010 was 13.1 percent, while mean retention from 2010-2011 through 2015-2016 was 20.4 percent. These means do not differ significantly. However, (2-tailed t-test: $t = -1.82$, $p = 0.11$; no significant departure from normality in sample data; variances not significantly different). This analysis may possibly be improved by using expanded catch and retention data for each regulatory year (National Marine Fisheries Service 2016c). Steelhead are rarely caught in ocean fisheries and retention of steelhead in non-treaty commercial ocean fisheries is currently prohibited.
