Garwin,

Can we talk about Reclamation's most recent attempt at a Work Plan? I don't really know what to do with it, maybe because I'm not sure what the final product should look like? I could use your perspective.

One thought I had was that there are a lot of management questions being considered so maybe we should "bin" the management questions into categories thereby simplifying and consolidating them? Maybe categories like: Questions to address biological objectives (temp mortality/year type; integration with the LCM; etc.), Questions to address resource objectives (storage targets, correlation between storage and cold water pool, etc.), and Questions to address technological and operational challenges (facility changes, available "knobs", etc.)? Interactions between objectives (storage, cold water pool and biological objectives)? Other???
