-- Slide 48: Second sub-bullet that says "Compliance with modified CVP delivery allocations." To be clear, shouldn't it say "NMFS amendment," with a clarification that the only thing adjusted/modified are CVP delivery allocations?"
-- Slides 75 & 78: Characterizing salmon mortality as an "example" seems to minimize the results, compared to the results from modeling a allocation cuts and lack of benefits, which appear to be more definitive/certain.
++ Slide 75: Suggest deleting the word "example,"
++ Slide 78: I don't know what you plan on saying using that slide, but it seems like the slide itself is not necessary, and especially with the word "example."
-- Slide 98: We can just acknowledge a little slippage in timeline as a result of the delays in scheduling workshop #4.
-- Slides 101-104: I'm sure you know, but make sure to delete this when sending out the pdf.
