Attached are a couple of handouts that were distributed during the Shasta RPA adjustments technical team meetings.

You saw Jeff R's e-mail with Reclamation's draft modeling workplan. My first thought was, seriously, why couldn't we engage in discussions about the workplan before getting a 20-page document?!?

During last Thursday's Shasta RPA adjustments technical team meeting, we talked about the following points to convey during this week's stakeholder meetings:

- We're sorting out what's appropriate for the adjustments process vs. the reinitiation of the CVP/SWP consultation
- We're working on biological objectives, then operations that meet those objectives
- Location-based temperature management (as opposed to current RPA that says temperature management to the downstream-most location that the cold water pool will provide)
- We're fine-tuning temperature management planning (e.g., March vs. February forecast, minimum Shasta and cold water volumes and which months)
- Development/refinement of modeling tools to help
