# Regulatory Context

- **National Environmental Policy Act**
  - **Alternative Development**
    - **No Action – Current Management Direction**
      - RPAs
      - California Water Fix?
      - Storage Projects?
    - **Alternatives**
      - Use screening tools to develop concepts to move forward
      - Evaluate RPA actions to determine the intent of each action
      - Propose alternative to RPA actions, as appropriate
      - Look at potential habitat restoration or mechanistic methods to achieve intent
      - Fresh look concept – Look at something completely different
      - Adaptive management component
    - **Number of Baselines**

# Regulatory Context

- **National Environmental Policy Act**
  - **Impact Analysis**
    - **Analytical Tools**
      - Peer reviewed for the most part – disclose when they have not been peer review and present results using other tools
      - Evaluate appropriate use of CALSIM III
      - Appropriate tools for groundwater analysis
      - Climate change analysis

# Regulatory Context

- **ESA Section 7 Consultation – Biological Assessment**
  - **Scope**
    - Proposed Action Area
    - Level of Analysis
    - Non Jeopardy Goal
    - Consistency with NEPA process
  - **Proposed Action**
    - Fresh look concept
    - Evaluate RPA actions to determine the intent of each action
    - Where appropriate, replace or modify RPA actions with actions that achieve the intent
  - **Environmental Baseline**
    - This should be fun!
  - **Effects Analysis**
    - **Analytical Tools**
      - Best Available Science
      - Peer Reviewed
      - Evaluate appropriate use of CALSIM III and other tools
      - Climate change analysis
