Hello Justin -

You are correct that Reclamation's Bay-Delta Office has not yet reached out to tribes for the ROC on LTO. However, this is something we should be doing and we will be working to schedule a tribal meeting to meet with them regarding the ROC on LTO and to determine what level of discussions they want at this point (G to G with the Regional Director or more frequent meetings with BDO staff and management).

We have not sent out any of the state, local or tribal cooperating agency letters yet, only the federal ones (NMFS, USFWS, EPA, etc). Last time there were over 700 organizations we sent letters to regarding cooperating agency status and therefore we are waiting until we get a contractor on board so they can handle the letters and cooperating agency memoranda of understanding. We hope to do this in October.

Please do not share schedules - we have not shared any schedule outside of the Core Team as we want to make sure things are accurate before distributing.

Can you please pass along the appropriate contact people and emails? We will ask our area offices as well, but would like to make sure we get the key players. We will add them to our email list for the ROC on LTO and reach out to them regarding this tribal meeting.
