As you know, Reclamation, DWR, USFWS, NMFS, and DFW signed a Memorandum of Understanding in December 2016 describing how we would coordinate on the Reinitiation of Consultation (ROC) on the Coordinated Long-term Operation (LTO) of the CVP and SWP.

Reclamation received a request in May from a group of our water contractors to be included in a revised Memorandum of Understanding regarding the Reinitiation of Consultation. As you know, the WIIN Act (Public Law 114-322) requires routine and ongoing coordination with public water agencies in the ROC on LTO. Reclamation and DWR have worked with the water users to propose revisions to the December 2016 MOU to include water users and work through other edits water users have requested to make the MOU consistent with the WIIN Act. We have largely come to agreement on the edits, with a few exceptions which are noted in the document

Therefore, it's timely we

share the draft revised MOU (attached) with you and see if your agencies have any concerns with the proposed edits to the MOU. We are hoping that you agree with us that most of these edits are reasonable, and that we can all sign a revised MOU with the water users.

, Reclamation plans to offer the full range of CVP and SWP water users the opportunity to sign.

If you do have concerns let me know. If not, stay tuned for the revised document for signature in the next few weeks. Thanks
