My apologies for not having our changes better presented in the draft, unfortunately they were already there buried in the track changes.

We have proposed changes in sections 2.1.6, 2.1.12, 4.17, 4.25 (to add Public Water Supplier as a definition), 5.2, and 5.4.7 (to add a requirement that PWAs be informed of how RPAs are economically and technologically feasible because the Ninth Circuit has said that this may not otherwise be necessary under the statute and regs).

The changes should show up highlighted in yellow except 4.17 where I have bolded the change.

As discussed at the meeting, let me know if you have any concerns but we think (obviously) that these changes improve the document.
