Thank you for your respective MOAs - they are very similar. How does this text sound?

"To facilitate compliance by DWR with CESA, the Federal agencies will involve CDFW, as the state agency with responsibility over fish and wildlife, in review of the Proposed Action for the Biological Assessment, regarding species that are dually listed."

The MOAs refer to DFW's participation or involvement. They also specifically mention dually-listed species, and USFWS or NMFS will request that the Federal action agency involve DFW.
